On 19 December 1988, the Karl-Theodor-Molinari-Stiftung e.V. (Karl-Theodor Molinari Foundation, registered association), which is the educational institution of the Deutscher BundeswehrVerband, or DBwV (Bundeswehr Association), was founded in Bonn as a registered association.

Educational work of the Foundation was officially taken up on 8 June 1989.

The Foundation continues and further develops, within a different organizational framework, the educational political work which had been accomplished by the DBwV for 25 years.

1. Objective and Tasks of the Educational Institution

The Foundation has the legal form of a "registered association" and, in accordance with its statutes, is a purely nonprofit institution focusing on education and training and the promotion of international cooperation on a democratic basis.

In order to fulfil these tasks, the Foundation has set up an adult education programme primarily offering seminars, symposiums, colloquia and conventions. In addition, the Foundation promotes basic and other scientific research work as laid down in its statutes.

The various seminars being offered are published in an annual programme and can be attended by all members of the DBwV as well as by any interested non-member.

Essential results of the Foundation's research work are published in its own "Dokumentationen" - (documentations) book series. Research studies carried out by the Foundation or third parties are published in the "Forschung aktuell" - (current research) series.

2. Bodies of the Foundation

In accordance with its statutes, the Foundation comprises the following bodies: the Committee, the Board of Trustees, the Assembly of Members and the General Assembly of the Members' Representatives.

a) The Committee

The Committee is elected by the General Assembly of Members for a period of four years and comprises the President, the Vice President and the Treasurer. It is responsible for all matters pertaining to the association and acts as the administrator of its assets. For running the day-to-day business, the Committee has appointed a Director and designated a number of personnel to assist him.

b) The Board of Trustees

The Board of Trustees which is also elected by the General Assembly of Members for a period of four years, acts as an advisory body to the Committee in all important matters. It consists of at least five and no more than nine members.

c) The General Assembly of Members

A General Assembly of Members is to be summoned at least once every four years. Its sole function is to elect and dismiss members of the other executive bodies, to decide on amendments to the statutes or the dissolution of the association, and to appoint honorary members.

3. Current Activities of the Foundation

At present, the Foundation organizes and conducts approx. 40 seminars annually with topics from the following areas:

- Sociopolitical issues and national, European and international politics;
- Social policy (old age insurance systems);
- Policy regarding Germany;
- European partnership activities;
- Rhetoric;
- Military Personnel Participation Act;
- Federal Personnel Representation Act;
- Occupational training and continuation training;
- Symposiums/scientific colloquia.

The Foundation's scientific work is emerging, inter alia, in the form of initial advancement programmes, cooperation activities with universities, and a dialogue with research institutions.
